Sealed item rate quotations are invited for the following work on behalf of the Registrar IIIT Delhi from Eligible Contractors for SITC and integration of **AV Equipment for Acoustic augmentation of Lecture Halls**, who have executed similar works ,so as to reach the office of the undersigned upto 3PM on 15/09/2014 in two envelopes to be opened on the same day at 3:30 PM, in the office of the Manager (Projects), Service Block, IIIT-D Campus, Okhla Phase-III New Delhi-110020 in presence of the intending bidders who so wish to attend.

Estimated Cost : Rs 5.7 lacs

EMD :Rs 11,400/-(Eleven Thousand Four Hundred only) in form of DD payable in favour of IIIT Delhi Collections.

1. The works shall be carried out as per the relevant CPWD / BIS Standards and Terms and conditions, Specifications, BOQ and areas/locations as directed complete.
2. **Time Allowed:** 30 days from issue of work order. The works may be carried out in phases and shall be subject to the satisfactory performance of the first installation and also availability of the lecture halls.
3. Schedule of quantity: As per enclosed BOQ and drawing .
4. Clause 12 of GCC CPWD is applicable for EI/SI.
5. Contractor must visit site before quoting and fully satisfy himself of the site conditions.
6. Contractor must possess valid DVAT certificate, TIN no.
7. No T&P shall be issued to the Contractor .The contractor shall be provided with electricity and water at one point ,he shall make his own arrangements for further distribution of electricity , water supply and all other labour ,tools, plant and equipment etc as required for the works complete. Any damage done to existing walls /ceiling /floors /electrical /fire alarm/ fighting/plumbing equipment /building during execution shall be on the part of the Contractor.
8. Eligibility Criteria: The agencies must preferably have satisfactorily executed three similar works in Govt Deptts/PSU/Reputed Pvt sector /MNCs each of value 40% of estimated cost or two works each of 60% of estimated cost or one work of 80% of estimated cost during last 7 years. The applications not supported with requisite experience certificates shall not be entertained.
9. The requisite certificates along with the EMD be enclosed in Envelope-A. The applications not supported with requisite experience certificates, valid DVAT certificate, TIN no shall not be entertained.
10. The priced bill of quantities kept in Envelope-B, all duly signed by the authorized signatory of the firms .
11. Payment shall be made as per actual quantities of executed works against Final bill.
12. Security deposit @5% shall be refunded after 6 months of completion.
13. Conditional offers will not be accepted. The offer shall remain valid for 30days.
14. IIIT-D reserves the right to accept or reject any tender in part or whole without assigning any reasons thereof. It may also reduce quantum of works if found unsatisfactory.

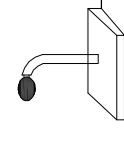

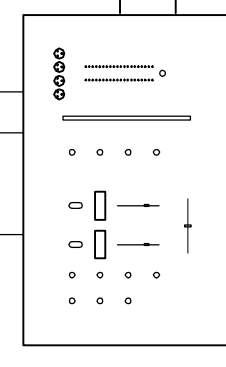
Existing Gooseneck Microphones



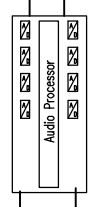
Neck Worn wireless Mic to be purchased



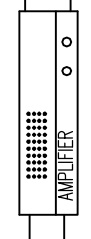
Existing Cordless Collar Mic

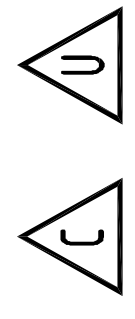
