Process of Online Document Verification & Admission

STEP 1: Make a payment of applicable Fees of Rs 2,12,000 through the Application Portal.

STEP 2: Upload the documents (mentioned in Table 1) in the portal (Latest by 10:00 AM on 16th September, 2021).

Candidate Part:

- 1. A document sequence is given in Table 1; candidates need to arrange the documents available with them in the same sequence.
- 2. Do the self-attestation, and mention the Application ID on each page.
- 3. Make all these a single PDF (with proper scanning).
- 4. Login into the portal and upload the above said PDF.

IIITD Office Part:

All the document submitted by the candidates will be verified by the officials of IIITD, and the candidates will be given a Provisional Admission Letter over the email.

Note: In case of failure to submit the required documents / payment of fee by 10:00 AM on 16th September 2021, your admission offer shall stand canceled.
