Tuition Fee Waiver Policy/Scheme for B. Tech. Students

I. <u>Eligibility</u>

- (i) The Scheme is open to only those who have passed class XII examination from Delhi, and grant of waiver is subject to discretion of the Institute The rejected application is not open to request or review
- (ii) The student should not have been availing financial assistance from any Govt. or the Scheme of the Govt. for meeting the cost of education in IIIT-D. In this regard, student will be required to submit an affidavit as per Annexure.
- (iii) The combined Gross Income (before deductions/rebates but including all the allowances) of both the parent in the previous Financial Year should not exceed the maximum limit specified below
- (iv) Tuition Fee paid in the last school attended should not exceed the limits specified below. The amount of Tuition Fee includes Tuition Fee, Examination Fee, Development Fee, Transportation Charges, Lunch, Books, Uniform, Sports, Cultural Charges, etc.
- (v) Fee Waiver is limited to the four years of the duration of the Program. A student needing additional time to complete required credits (including those who repeat the first year) will not get any waiver in the repeat year and beyond.
- (vi) A student needs to maintain a CGPA higher than 6 at all times to remain eligible for continuing to receive the fellowship. Moreover, the student should not receive an "F" grade in any subject.

Those not fulfilling the above requirements need not apply.

II. Tuition Fee Waiver Limits

A student fulfilling the requirements mentioned above is eligible for fee waiver as per income criteria and limits mentioned below:

III. Mandatory Documents in Proof of Income

Student should enclose following documents, as applicable, failing which application will not be considered. All documents must be enclosed for waiver as per the table above, including for the BPL Category. Documents submitted after the last date will not be considered:

- (i) BPL/NFS card in case of those belonging to the BPL category,
- (ii) Copy of the complete Income Tax Return (including the acknowledgement page) for both the working parents for the previous Financial Year. In the case of a non-working parent, an affidavit affirming non-employment certified by the office of the SDM,
- (iii) Copy of Form 26AS for the Financial Year of fee waiver,

- (iv) Copy of the Income Tax Annual Information Statement for the Financial Year of fee waiver,
- (v) A declaration about the number of Bank accounts, and the copies of the Bank (s) Statements for the previous and current FY up to the date of application.
- (vi) For fee paid in the last school attended, invoice/copy of challan raised by the school along with document in support of payment such as receipts etc. Letter etc. provided by the School certifying payment will not be accepted.
- (vii) Copy of bank Education Loan certificate, if availed,
- (viii)Copy of Declaration for financial assistance in the form of Affidavit as per Format below.

IV. Disqualification Due to False Information

If at any stage, it is found that the applicant has submitted wrong or false information then the recipient student will refund the entire amount forthwith along with penal interest @ 10% for the period of credit of amount to his bank account and until the date of refund. The Institute, at its discretion depending upon circumstances, may also initiate criminal proceedings against the parents / recipient student.
