## RULES AND PROCEDURES FOR SPOT ROUND Admission M.Tech. (CSE & ECE) 2022-23 Announced on 14<sup>th</sup> July 2022

SPOT Round admissions will be conducted Offline in IIIT-Delhi campus on July 26, 2022 (Tuesday) to fill the vacant seats (if any) in M.Tech. (CSE) & (ECE) programs for both GATE and Non-GATE candidates. Exact number of vacancies will be announced on July 23, 2022 (Saturday)

The eligibility and application process etc. are given below;

### 2. Who are eligible to participate in spot round

Candidates who have already done ONLINE registration after paying Rs.500/-, and are in the merit list available on IIIT-D Website (<a href="https://www.iiitd.ac.in/admission/mtech/2022">https://www.iiitd.ac.in/admission/mtech/2022</a>) are eligible to participate in SPOT Round. Out of those candidates following category are eligible to apply for spot round

- i) The registered candidates in merit list who have not been offered any seat up to Fourth Round.
- ii) The candidates who have withdrawn their admission at any stage.
- iii) The candidates who have been allotted a seat in some round but did not accept the offer of admission.

**Note**: Candidates who have already accepted the offer of admission and not taken withdrawal are NOT allowed to participate in spot round.

### 3. Procedure for spot round

The above-mentioned eligible candidates have to follow the following steps in order to participate in SPOT Round:

- i) Candidates have to submit their willingness for participation by 24<sup>th</sup> July 2022 (Sunday),
   05:00 PM by filling this <u>FORM</u>.
- ii) After filling the online form, all interested candidates must get a Demand Draft issued for

- Rs. **90,000/-** in favour of **"IIITD Collections"** payable at New Delhi before reporting for the SPOT Round Venue.
- candidate must report at SPOT Round Venue, Room No. C102, Seminar Building, IIIT- Delhi, Okhla Phase III, Delhi-110020 on 26<sup>th</sup> July 2022 at 08:00 AM. Candidates must bring all original documents and one set of self-attested photocopies of the documents as mentioned in Point No. 5. (Those who have filled the above willingness form and are not available physically for SPOT Round can't claim their candidature for Spot round; no separate communication will be made to candidates who have submitted the online willingness form.)
- iv) Candidates will be called in rank-wise order on the day of SPOT Round and will be offered admission from the available vacant seats.
- v) If a candidate is called and s/he chooses a seat and the seat is offered to him/her, then it will be announced for the information of all and the same seat will be deducted from the vacancy. Vacancy list will be presented during session for instant verification of vacancy position by other candidates during the spot round.
- vi) The candidate who accepts the admission offer in spot round need to pay the balance fee i.e. Rs.75,334/- within two days through the following link; <a href="https://payments.iiitd.edu.in/pg/fees/pg.html">https://payments.iiitd.edu.in/pg/fees/pg.html</a>, else his/her offer of admission will be cancelled and the fees paid for acceptance of seat in SPOT Round (Rs.90,000/-) will be forfeited.
- vii) The candidate who accepts the offer in spot round will give his/her consent through an undertaking with the following format;
  - "I am accepting the offer of admission in M.Tech. (CSE/ECE) program with <<u>name of the specialization allotted during spot round</u>> specialization (if applicable) allotted during IIIT-Delhi M.Tech spot round held on <date>. I understand that if I fail to make the remaining payment of Rs.75,334/- by <Date>, then my offer of admission will stand cancelled and spot round acceptance fee of Rs.90,000/- will be forfeited."
- viii) The documents verification of the candidates who will accept the offer of admission on the day of spot round admission will be done on the same day. In case the documents are not found in order, the admission offer will be cancelled and the same seat will be offered to the next candidate in the order of Merit as per published merit list.
- ix) If a candidate who is not getting his/her preferred choice as per his/her rank during spot round, s/he can opt out of spot round and the spot round acceptance Demand Draft of Rs.90,000/- will be returned to him/her. S/he need to submit an undertaking as per the following format;
  - "I am not satisfied with the offer of admission in M.Tech. (CSE/ECE) program with <name of the specialization allotted during spot> specialization allotted during IIIT-Delhi M.Tech Spot

round held on <date>. I understand that if I am opting out of this then the same seat will be allocated to some other candidate who is below my rank.

I request to refund my demand draft of Rs. 90,000/-"

- x) Whenever the seats are exhausted in any program/specialization, it will be announced in the spot round session and remaining candidates will be asked to leave.
- xi) The process will go on till the seats are exhausted or there are no candidates available for offer of admission.
- xii) The Institute reserves the right to change the spot round process. The Institute also reserves the right to fill the seats fully or partially at its own discretion without assigning any reasons thereof.

### 4. Hostel Allocation

## After the seat is allocated student may apply for hostel allocation on the same day as per the following process;

- 1. The hostel for the student who belongs to outside Delhi and with more than 15/20 km's from the Institute will be allocated on the day of the reporting after the Physical Document Verification.
- 2. The induction program is scheduled from 27th-30th July, 2022.
- **3.** Hostel Fee for Monsoon 2022 Semester starting from 01<sup>st</sup> August 2022 onwards will be as per below table:

- 5. Security Deposit of Rs. 10,000 is refundable at the time of completion of the program.

  DD must be in favor of "IIIT Delhi Collections" payable at New Delhi.

The duly filled in Hostel Allotment Request Form needs to be submitted on the day of Physical Document Verification & Hostel Allotment along with a copy of Address Proof & the receipt of Hostel Fee Payment.
