RULES AND PROCEDURES FOR SPOT ROUND Admission M.Tech. (CSE & ECE) 2023-24 Announced on 19th June 2023

SPOT Round admissions will be conducted online on 27th June 2023 (for M.Tech. CSE) & 28th June 2023 (for M.Tech. ECE & CB) to fill the vacant seats (if any) in M.Tech. (CSE) & (ECE) programs for both GATE and Non-GATE candidates & M.Tech. (CB) program for GATE. Exact numbers of vacancies are as below:

2. Who are eligible to participate in SPOT Round

Candidates who have already done ONLINE registration after paying Rs.500/-, and are in the merit list available on IIIT-D Website (https://www.iiitd.edu.in/mtech2023/) are eligible to participate in SPOT Round. Out of those candidates following category are eligible to apply for spot round

- i) The registered candidates in merit list who have not been offered any seat up to Fourth Round.
- ii) The candidates who have withdrawn their admission at any stage.
- iii) The candidates who have been allotted a seat in some round but did not accept the offer of admission.

Note: Candidates who have already accepted the offer of admission and not taken withdrawal are NOT allowed to participate in spot round.

3. Procedure for SPOT Round

The above-mentioned eligible candidates have to follow the following steps in order to participate in SPOT Round:

- i) Candidates have to **submit their willingness** for participation by **25**th **June 2023** (Sunday), 05:00 PM by filling this <u>FORM</u>.
- ii) Before filling this form all the candidates who wish to participate in the SPOT Round

need to pay a participation fee of **Rs. 90,000/-** via **this link** by selecting **"M.Tech. 2023 SPOT Round Fee"** from the "Select Payment Purpose" drop-down and upload the fee receipt **here**. (This amount will be refunded to those who will not get or accept any seat in SPOT Round)

- iii) After paying the participation fee, the candidate needs to submit the documents in this <u>form</u>. The guidelines for submitting the documents are as below
 - A document sequence is given in Table 1; candidates need to arrange the documents available with them in the same sequence.
 - Do the self-attestation, and mention the IIIT-D Application No. on each page.
 - Fill the undertaking form properly by tick (V) marking the relevant point/s.
 - Make a single PDF of all the documents (max size-25 MB) with proper scanning and making sure that the document is readable)
 - Upload the PDF in the above google form.

- iv) Candidates will be called in rank wise order over google meet/zoom online on the day of spot round and will be offered admission from the available vacant seats.
- v) Google meet/Zoom link and schedule will be informed to the registered and eligible candidates on 26th June 2023 late evening. Depending on the number of registrations, the

candidates may be invited in different slots, rank wise. Candidates are advised to check the registered email on regular basis.

- vi) If a candidate is called and s/he chooses a seat and the seat is offered to him/her, then it will be announced for the information of all and the same seat will be deducted from the vacancy matrix. Vacancy list will be presented during google meet/zoom session for instant verification of vacancy position by other candidates during the spot round.
- vii) The candidate who accepts the admission offer in spot round need to pay the balance admission fee i.e. Rs. 1,22,000/- (for CSE & ECE) & Rs. 45,334/- (for CB) within two days (by 29th June 2023 till 05:00 PM), else his/her offer of admission will be cancelled and the fees paid for participation in spot round (Rs.90,000/-) will be forfeited.
- viii) The candidate who accepts the offer in spot round will have to immediately give his/her consent from his/her registered email id to mtech-admissions@iiitd.ac.in with the following format:

"I am accepting the offer of admission in M.Tech. (CSE/ECE) program with <<u>name of the specialization allotted during spot round</u>> specialization (if applicable) allotted during IIIT-Delhi M.Tech spot round held on <date>. I understand that if I fail to make the remaining payment of Rs. 1,22,000/- (for CSE & ECE) & Rs. 45,334/- (for CB) by <Date>, then my offer of admission will stand cancelled and spot round participation fee of Rs.90,000/- will be forfeited."

- ix) The document verification of the candidates who will accept the offer of admission on the day of spot round admission will be done on the same day. Students are advised to submit their documents maximum by 25th June 2023 (Sunday) till 05:00 PM. In case the documents are not found in order, the admission offer will be cancelled and the entire fee paid will be forfeited.
- x) If a candidate who is not getting his/her preferred choice as per his/her rank during spot round, s/he can opt out of spot round and the spot round participation fee of Rs.90,000/-will be refunded to him/her. S/he need to email this from his/her registered email id to mtechadmissions@iiitd.ac.in in the following format:

"I am not satisfied with the offer of admission in M.Tech. (CSE/ECE) program with <name of the specialization allotted during spot> specialization allotted during IIIT-Delhi M.Tech Spot round held on <date>. I understand that if I am opting out of this then the same seat will be allocated to some other candidate who is below my rank. I request to refund my participation fee of Rs. 90,000/-"

- xi) Whenever the seats are exhausted in any specialization, it will be announced in the google meet/zoom session.
- xii) The process will go on till the seats are exhausted or there are no candidates available for offer of admission.
- xiii) The participation fee will be refunded to the candidates who are not allocated any seats during the spot round.

4. Important Note:

- i) The Institute reserves the right to change the spot round process. The Institute also reserves the right to fill the seats fully or partially at its own discretion without assigning any reasons thereof.
- ii) Candidate need to ensure Good internet speed, that supports a video call, with possibly negligible interruptions/ drop-outs. Do test your internet connection before the day of the spot round so that you can be certain that it is working.
- iii) Be available for the spot round in a room where you are alone so that you are not disturbed.
- iv) Do make sure the lighting in the room is good and make sure whatever is behind you is simple and appropriate.
- v) Do set the camera up so that you are seen from the waist up.
- vi) Institute will not be held responsible for failure of any internet connection during the online spot round seat allocation process. And if during the announcement of rank s/he is not available, the process will be moved to the next ranked candidates.

5. Hostel Allocation

Process of Hostel Allocation (after completing the Part 1 and Part 2 Process):

- 1. The hostel for the students belongs outside Delhi and with more than 30 km's from the institute will be allocated on the day of the reporting after the Physical Document Verification.
- 2. The induction program is scheduled from 30th June to 2nd July, 2023.
