



Title: Professor of Practice/ Visiting Faculty in Social Sciences and Humanities Department (Entrepreneurship)

The Department of Social Sciences and Humanities (SSH) at Indraprastha Institute of Information Technology (IIIT-Delhi) is looking to hire Professor of Practice/ Visiting Faculty for the Entrepreneurship minor program for the term beginning January 2022 or August 2022.

Essential Qualifications & Experience:

The eligibility criteria and the necessary qualifications will be based on the courses and/or research activities for which such faculty are being hired. The candidates must preferably hold a PhD, but it is not an essential criterion. However, this requirement will be waived if she/he has a good academic record throughout in any discipline from a reputed educational institute with over 15 years of industry experience for Professor of Practice. The applicant will have specialist knowledge in the domain, expertise that will complement the available expertise within IIIT-Delhi and be able to bring practice-oriented teaching frameworks into the classroom.

- The candidate must possess strong communication skills.
- Should have some teaching experience.
- Preference will be given to candidates having a good track record of teaching at the undergraduate (as indicated by student feedback).

Desirable:

- Having a record of entrepreneurship and incubation related activities.

Appointment Method:

These positions will be offered on a consolidated basis for a limited period of up to 3 years. The appointment may be on full-time or part-time basis.

- Appointment for 1 year or less is done through the Standing Committee. Such appointments can be renewed, up to a maximum of 3 years on a yearly renewal basis, based on their performance in the previous year(s), and the need of the Institute/ Department.
- Appointments for 3 years or more are to be done through the Faculty Selection Committee.

Responsibilities/Expectations:

- The candidate is required to have proficiency in teaching the following courses: Entrepreneurship courses.
- They may be involved in designing and teaching courses, research and development activities, setting up research collaborations, promoting industry-institute linkages, consulting assignments, entrepreneurship-related activities, contribute in placement-related activities and other institutional initiatives.
- For a full time position the faculty member is expected to teach two courses (of 4 credits each) per semester, and a part-time faculty member is expected to teach one course (of 4 credits each) per semester.
- They are also expected to help in some Institute administrative functions such as members of committees, helping in various events and initiatives, etc.
- Any other responsibility assigned on an ad-hoc basis by the Head of the Social Sciences and Humanities Department and/or the Director of the Institute.

Pay and Other Benefits

- The overall compensation will be ranging from Rs.1.24 Lac – Rs.1.86 Lac per month, in the visiting faculty consolidated scale, which is defined from time to time by the Board, as per the expertise and domain knowledge. The compensation of a part-time faculty is proportionate to the number of days expected in the appointment (e.g. a half-time appointment will be offered half of the full-time consolidated). The part-time faculty member is paid proportionate remuneration to the weekly workload of the full time faculty member. Additional allowances may be permitted by the Director on a case-by-case basis.

General Information/ Conditions/ Instructions

- The position is contractual on purely ad-hoc basis for a maximum of up to three (03) years and will be subject to semester - wise evaluation of teaching.
- Prescribed qualifications are only a minimum requirement and merely possessing the same will not entitle a candidate to be called for an interview. In this regard, the decision of the Institute/ Screening Committee will be final and no request for reconsideration etc. will be entertained through any means.
- Only shortlisted candidates will be informed about interview and presentation dates through e-mail.
- The Institute reserves the right to restrict the number of candidates invited for interview and presentation to a reasonable limit, on the basis of qualifications and experience.
- The Institute also reserves the right to reject any or all the applications without assigning any reasons thereof.
- Number of positions may be increased or decreased depending on the requirements.
- The Institute works for five days a week. National Holidays are followed as per the Govt. of Delhi notification.
- Shortlisted candidates will be asked to provide three letters of recommendation.
- These faculty members will not be eligible for campus housing.
- All faculty in this category will be governed by the Act, Statutes, Ordinances, and Board decisions.
- Any candidate working in Govt. Organization/ Autonomous Bodies/ PSUs etc. will be required to produce the No Objection Certificate before the interview and should send his/ her application through proper channel.
