(Note: The bidders having valid registration with NSIC/MSME may avail exemption from submission of EMD but must enclose valid NSIC / MSME certificate/document with registration for similar works in envelope No. 1 instead of EMD demand draft. However, all bidders irrespective of their registration with NSIC/MSME have to submit the requisite Tender Fee).

In the best interest of the IIITD and bidders, the bidders are advised to study the Institute's Audio-Visual System on site as per the configuration/specifications/working condition as indicated in Annexure-A before submission of their bid. Contractor must visit site before quoting and fully satisfy himself of the site conditions. No exemptions shall be made for lack of knowledge of site conditions. The scope of work includes:

The interested agencies may submit their Technical Proposal along with the following documents, duly authenticated and stamped by the proprietor or authorized signatory:

If there is any addendum/corrigendum related to tender, it shall only be published on IIITD website (https://www.iiitd.ac.in/tenders). The Bidders are advised to check IIITD website regularly. No other mode of notice will be given.

If the last date of receiving/opening of the bids coincides with a holiday, then the next working day shall be the receiving/opening date

Scope of Work:-

- 1. The Audio-Visual System is located in IIITD Campus Okhla Phase-III New Delhi. The selected vendor will be required to maintain the system in the mentioned site.
- 2. The Vendor shall undertake contract for all items under AMC.
- 3. The contract shall include all components including all the parts but excludes the consumables like Lamp, Batteries, Cables (VGA, HDMI, etc.)
- 4. Installation of necessary firmware/updates/upgrades / patches shall be provided and carried out

- as part of the contract at no extra cost wherever it is required.
- 5. Repairs /Replacement of all equipment/parts during CAMC period to provide smooth operation of the same.
- 6. Quarterly preventive maintenance of equipment under the AMC and the report for the same should be submitted for all the machines under contract.
- 7. The maintenance services will be provided on all working days (Monday to Saturday).
- **8.** Provision of availability of experienced service engineers on Sundays or other holidays should be ensured in case of exigencies.
- **9.** Additional engineer/(s) may be deputed at IIITD in addition to the above resident engineers whenever there are more workload/complaints to rectify the equipment within the stipulated response time.
- **10.** All Podiums, peripherals, accessories and their parts as mentioned in tender document will be covered under this maintenance contract.
- 11. The parts/accessories/components/converters/sub-assemblies used for repair/replacement by the contractor will be of the same/equivalent or higher make and functional capability as originally available in the systems. Except for consumables like Lamp, Batteries, screen fabric Cables (VGA, HDMI, etc.). The contractor must provide alternate/substitute/service parts//accessories/components/converters/sub-assemblies/equipment to keep the system running till the new ones to be changed arrive and are commissioned successfully. Penalty shall be levied as per Cl16 till such items are put in working order.
- 12. The equipment that are not serviceable by the vendor due to obsolescence of technology or non-availability of parts/components/assemblies will be withdrawn from the maintenance contract. The decision of IIITD regarding non-availability and obsolescence of technology will be final. Withdrawal of such systems shall be communicated to the vendor and equivalent maintenance charges shall be deducted from the amount due to the vendor.
- **13.** Qualification and experience of the resident engineers/technicians shall be agreeable to IIITD. No frequent replacement will be allowed.
- 14. Comprehensive AMC includes free attendance to all service call and paid repair/replacement of all defective parts by equivalent or higher model except the consumables.
- 15. The vendor will be responsible for the trouble-free integrated working of the Audio-Visual System. A full time resident engineer- AV technician with minimum10 years of experience shall be deployed to enable the same in case opted for by IIITD as per BOQ.
- 16. Response Time: Within 8 Hrs any delay beyond that shall be penalized at Rs 500/- per day.
- 17. Resolution Time: After response time, the resolution time is 24 working Hrs.
- 18. In order to maintain the rooms up and operational, the equipment will be maintained in the good working condition at the current specification and functionality.
- 19. During the period of the contract the Institute will not allow any unauthorized person to handle the system in order to rectify any defect.
- 20. Vendors can be called for deployment of additional technician/engineers for VVIP programmers/Convocation etc. limited to 4 such events per year free of cost in addition to the Resident Engineer.

21. Any of the above mentioned systems may be withdrawn at any time during the period of contract; Maintenance charges for such equipment will be payable at pro- rata basis. Similarly equipment can be added during the period of AMC and maintenance charges will be paid pro-rata basis

Bidder Qualification Criteria

Contractors who fulfil the following requirements shall ONLY be qualified for financial bid opening (Joint Ventures are not accepted):

1. Performance/Work Experience: Should have satisfactorily completed the works as mentioned below during the last Seven years ending previous day of last day of submission of bid in Central Government Department/State Government Department/Central Autonomous Body State Autonomous Body / Central Public Sector undertaking. /PPL/State Public Sector undertaking /City Development Authority/Municipal Corporation of City formed under any Act by Central/State Govt. and published in Central/State Gazette and be either manufacturer or its authorized agents only.

One similar work of value not less than Rs. 12,00,000/-

OR

Two similar works, each of value not less than Rs. 9,00,000/-

OR

Three similar works, each of value not less than Rs. 6,00,000/- all amounts rounded off to a convenient full figure.

Note: Similar work shall mean: Comprehensive Annual Maintenance and Operation of Audio-Visual Equipment.

- 2. **Annual Financial Turnover:** Annual Turnover of minimum Rs.20.00 lakhs during the immediate last three consecutive financial years, ending on March 31, 2022 (Copy of certificate from chartered accountant to be submitted)
- 3. Shall have a solvency of Rs. 6.00 Lakhs. The applicant shall submit the solvency certificate, not older than six months prior to 31st Oct 2022, issued by any scheduled bank, in original.
- 4. Submission of requisite fee for the cost of the Tender
- 5. Submission of EMD or valid NSIC / MSME certificate/document.
- 6. The bidder must have their own service centre/operating office set up in Delhi/NCR and they should have complete tools for support /repair of audio video equipment and peripherals. (Physical inspection may be done by officials)
- 7. Self-attested undertaking that the firm has never been black listed by any Government Department / Ministry / Organization / PSUs / Autonomous bodies / Statutory bodies etc. (Self declaration from the bidder in company letter head, signed by authorized signatory)
- 8. Bidder must have sufficient Technical & supervisory staff proficient in managing the tender service (Please enclose undertaking on bidder's business letterhead signed by the authorized signatory
- 9. Only manufacturer/authorized dealer/System Integrator of Harman/Christie/Kramer OEM are eligible to bid and provide unconditional support for execution of contract as well as period of AMC. Tender specific Authorizations from Harman/Christie / Kramer needs to be attached along with bid submission. Without Authorizations from Harman/Christie / Kramer bid will be rejected/disqualified.

- 10. The bidder Should have a Permanent Account Number (PAN) / GST No.
- 11. The bidder Should have a EPF & ESIC Registration
- 12. GST registration Certificate of the State in which the work is to be taken up as must to be submitted.
- 13. Email and mobile no. of the firm/ agency on the letter head of firm/ agency (For making correspondence).

The bidder must comply the above-mentioned eligibility conditions. If any bidder does not fulfill the same, they will be technically rejected

TERMS AND CONDITIONS

- 1. The contract is initially for a period of one year. The contract will be reviewed yearly, and may be extended for a period of maximum of three years. However, Institute at its discretion, can terminate the contract without citing any reason at any point of time by giving three (1) month notice. In case of termination, Institute will be liable to pay prorata amount to the vendor only for the period for which the AMC services availed by the Institute. On mutual consent, contract may be extended for a further period of two years on the same rates, terms and conditions.
- 2. The Audio-Visual System is located in IIITD Campus Okhla Phase-III, New Delhi. The selected vendor will be required to maintain the system in the mentioned site.
- 3. Logistics: The customer shall provide all the necessary permits, forms and documents if any required for the movement and avoidance of octroi/entry tax if any.
- 4. The contractors are advised to get acquainted with the proposed work and its site and special conditions carefully before tendering. No claim of any sort shall be entertained on account of any site conditions and ignorance of specifications and special conditions.
- 5. Prices quoted should be for Institute premises and should be all inclusive of statutory taxes, fees, cesses, any duties, levies, charges, surcharges and other components, etc. except GST which is to be shown separately.
- 6. During the contract period, any hardware/equipment under AMC may be removed from the contract as per the requirement of the Institute and the same will be informed to the vendor through a formal communication. In such cases, the amount against the removed AV Equipment from AMC will NOT be invoiced by the firm from the date of the Institute's communication. Similarly, any additional hardware/equipment may be added under AMC during the contract period at the AMC contract rate of the respective hardware. In case the rate for the respective hardware is not available in the contract, AMC for the same may be awarded at a mutually agreed rate as per prevailing market condition and practice in the industry. The invoice for such AV Equipment under AMC will be invoiced by the firm from the date of acceptance of the Work Order for the same.
- 7. The successful bidder has to submit the security deposit /performance guarantee from nationalized bank of equivalent amount of 3% of the contract value within 10 days of issue of order on awarding the contract but before execution of the agreement, to cover any loss or damage caused to or suffered by the Institute due to acts of commission and omission by the successful bidder or any failure on the part of the successful bidder in fulfillment of terms and conditions of the contract and conditions contained in the agreement. The Bank Guarantee shall have to remain valid for the entire duration of the Contract plus three months beyond the completion of contract period. The successful bidder shall not be entitled to any claim or receive any interest on the amount of performance guarantee. The EMD of the successful bidder will be refunded after submission of the performance Guarantee/Security Deposit. Successful bidder may also submit the performance guarantee in the form of demand draft payable to IIIT-Delhi Collections.
- 8. The rates quoted by the contractor shall be taken as net and nothing extra shall be paid on any account i.e. royalty, cartage, taxes and stacking at required places etc.
- 9. The contractor shall make (4) visits during one year on quarterly basis for checking the complete system.
- 10. In case of any breakdown the contractor shall visit site to attend the breakdown.

- 11. Payment shall be made on quarterly basis.
- 12. The technical proficiency and the behavior of the staff to be engaged shall be checked along with the credentials of the staff and only those who pass the above criteria shall be engaged at the site.
- 13. The department reserves the right to close the contract at any time during the currency of the contract and 7 days' notice will be issued to the contractor without giving any compensation.
- 14. The rates quoted shall be inclusive of all taxes i/c GST.
- 15. Escalation matrix up to the level of CEO must be provided with phone numbers and email addresses of all personnel in the matrix.
- 16. This is purely a service contract. All the staff engaged by the contractor shall solely be his liability and this department, in no way, shall be held responsible for any compensation for any of their acts/accidents.
- 17. In case of any accident during the maintenance of the equipment leading to injuries, damages to human being, equipment and or loss of life, the contractor shall be fully responsible for setting all claims and indemnity. In this respect no compensation shall be made by the department. inquiry office & shall be produced as and when required by higher officer of deptt. Otherwise recovery @ Rs. 1000/-. per month will be made from the bill.
- 18. Repair/replacement shall be done at the direction of Engineer-in-Charge to keep the system in healthy condition and with minimum down time.
- 19. In addition of above T&P if any special T&P shall be required, the same shall be arranged by the contractor within the scope of work for which nothing extra shall be paid.
- 20. Technical staff shall visit the site and check the complete system, including all of the above mentioned sub systems, once in a quarter and carry out the required preventive maintenance to avoid break downs. The service slips/ log books for every visit shall be got signed from Engineer-in-Charge regularly.
- 21. All installations shall be kept clean and safe from risk of Fire/Theft/Accidents and damage etc.
- 22. The contractor shall bring to the immediate notice of the department any defect/malfunctioning of any of the system, sub system or equipment and machinery which requires attention of the department if not otherwise covered by the scope of the contract.
- 23. Dismantled materials if any resulting from the replacement or repair shall be returned to the Engineer in charge
- 24. The rates should be inclusive of all taxes & the agency has to pay bonus to their worker /ESI/PF/Gratuity to staff engaged for this work, according to labour law as applicable.
- 25. Proof of deposit of provident fund and ESI contribution can be demanded any time by the Engineer in Charge.
- 26. The contractors shall pay the wages & allowances as applicable and revised time to time by the Govt. and submit the proof of increasing wages paid to the workers deployed for re-imbursement/claim under Clause 10C of agreement.

- 27. ESI & EPF shall be reimbursed to the firm as actual basis paid by the firm after production of proper documentary evidence.
- 28. The Contractor shall pay to the engaged staff according to minimum wages act on or before 10th day of every month by ECS or by Cheque only & submit copy of same with bill duly verified by Engineer-in-Charge.
- 29. The contractor whose bid is accepted will also be required to furnish either copy of applicable licenses / registrations or proof of applying for obtaining labour licenses registration with EPFO, ESIC & BOCW welfare board.
- 30. All standard protocols such as wearing masks, using sanitizer, maintaining safe distancing norms must be followed by the Contractor and his workers to prevent spread of coronavirus failing which expulsion/penalty shall be levied on the agency.
- 31. The workers shall be scanned for temperature before entry as per norms and actions per policy taken.
- 32. All workers are supposed to use identified utilities of the Institute only.
