- Works of monitoring and reporting of Environmental parameters of Drinking/Domestic/STP
 Water, air and noise pollution shall be carried out as per DPCC, MOEF requirements for
 environmental monitoring collection of data or any requisite information, monitoring of ambient
 and indoor air quality, noise levels through specialized equipment accredited laboratories for
 submission to stakeholders/on website /DPCC/MOEF including sampling, analysis, report
 submission.
- 2. The firm should be Govt. Approved and ISO-9001
- 3. The firm should have NABL accredited Laboratory (In house/ Empanelled/ Group company's) with adequate staff and experts with at least 5 years of experience.
- 4. The firm should preferably have experience of working with Educational Institutions as IIT's/IIMs'/IIIT's or equivalent reputed Govt. Institutes/Universities.
- 5. The firm should have its branch office/registered office/head office in Delhi/NCR.
- 6. The firm/its Director should have undertaken similar assignments of Environmental Monitoring and reporting not less than 10 nos (Completed projects / running projects) with three similar works each of value Rs 1.00 lac of annual estimated cost or two works each of Rs 1.5 Lac of annual estimated cost or one work of Rs 2 Lac of annual estimated cost in the last 7 years. Copy of experience certificates /work orders to be enclosed.
- 7. The firm should have average annual turnover of Rs. 10 lacs during last three financial years.
- 8. Work to be commenced within 7 days from date of award letter.
- 9. Schedule of quantity: As per enclosed BOQ.
- 10. The contract shall be initially for a period of 1 year (12 months) renewable on performance basis for a further period on mutually agreed terms.
- 11. Sample test locations will be informed after award of works and will be as per site conditions/instructions of engineer in charge/TPIA, this may implies that number of test may increase or decrease.
- 12. Contractor must visit site before quoting and fully satisfy himself of the site conditions.
- 13. No T&P shall be issued to the Contractor. The contractor shall be provided with electricity and water at one point. All other skilled/unskilled labour, tools, plant and equipment loading unloading transportation of equipment etc as required for the works complete shall be contractor's responsibility. Any damage done to existing walls /ceiling /floors /electrical /fire alarm/ fighting/plumbing equipment /building during execution shall be on the part of the Contractor.

- 14. Contractor have to made his own arrangement for stay of its laboratory team & will be solely responsible for safety /security of equipment during measurement/monitoring is required at all times.
- 15. The requisite certificates along with the EMD (Bid Security Declaration to be submitted as per Annexure-XX) be enclosed in Envelope-A. The applications not supported with requisite experience certificates in respect to all the above points wherever required & GST registration certificate shall not be entertained.
- 16. The priced bill of quantities kept in **Envelope-B**, all duly signed by the authorized signatory of the firms.
- 17. Payment shall be made as per actual quantities of executed works against RA and final bills.
- 18. ESI/PF will be borne by contractor and will not be reimbursed by IIITD separately.
- 19. Rate shall be inclusive of all taxes, duties etc complete.
- 20. Conditional offers will not be accepted. The offer shall remain valid for 21 days.
