- 1. The works shall be carried out as per the relevant CPWD / BIS Standards and Terms and conditions, Specifications, BOQ and areas/locations as directed complete.
- 2. **Time Allowed**: 20 Days from issue of work order.
- 3. Schedule of quantity: As per enclosed BOQ.
- 4. Clause 12 of GCC CPWD is applicable for EI/SI.
- 5. Contractor must visit site before quoting and fully satisfy himself of the site conditions. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the work.
- 6. Contractor must possess valid GST, PAN and TIN no.
- 7. No T&P shall be issued to the Contractor .The contractor shall be provided with electricity and water at one point, he shall make his own arrangements for further distribution of electricity, water supply and all other labour ,tools, plant and equipment etc as required for the works Any damage done to existing walls /ceiling /floors /electrical /fire alarm/ fighting/plumbing equipment /building during execution shall be on the part of the Contractor.
- 8. Eligibility Criteria: The agencies must have satisfactory executed civil works in Govt Deptts/PSU/Reputed Pvt sector /MNCs a three works each of value of Rs 1.20 Lac or two works each of value 1.8 Lac or one work of value 2.40 Lac during last 5 years to submit the experience certificates for the works and registration certificates with Govt. Depts. if any. The applications not supported with requisite experience certificates shall not be entertained
- 9. The priced bill of quantities, all duly signed by the authorized signatory of the firms. This will be enclosed in Envelope- II.

10. Payment shall be made as per actual quantities of executed works against RA/Final bill at all locations as directed.

- 11. Defect Liability period 6 months from date of completion.
- 12. Security Deposit / Retention money shall be **Three percent (3%)** of the value of executed works and will be deducted from each and every payment made to the contractor against running account bill submitted for the work done at site.
- 13. Conditional offers will not be accepted. The offer shall remain valid for 60days. The rates shall remain firm for a period of one year from date of award. The work order may be extended to cover additional areas at same rates as per institute requirements. No variation in rates shall be applicable.
- 14. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the IIITD Engineers, responsible for supervision of work, on regular basis.
- 15. Rates to quoted are inclusive of all taxes, duties, cartage, loading unloading and shifting to location as called for
- 16. Contractor will take due permission for entry of all his workers in IIITD. No unauthorized person will be allowed to work inside.
- 17. During execution of work, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
- 18. All standard protocols such as wearing masks, using sanitizer, maintaining safe distancing norms must be followed by the Contractor and his workers to prevent spread of coronavirus failing which expulsion/penalty shall be levied on the agency.
- 19. The workers shall be scanned for temperature before entry as per norms and actions per policy taken.
