### **INVITATION FOR BIDS**

- 1. Indraprastha Institute of Information Technology (IIIT-Delhi), Delhi a State University created by an Act of Govt. of NCT of Delhi, invites sealed financial bids for the purchase of 40 in number Computer Desktops (as per specification mentioned under Scope of Work below) for its campus at Okhla Phase-III New Delhi-110020.
- 2. An amount of Rs.50, 000/- (Rupees Fifty Thousand only) towards earnest money (EMD) must be deposited in the form of Demand Draft in favor of IIIT-Delhi, payable at New Delhi. No interest shall be payable on the earnest money deposited by the bidder. Tender Document without earnest money will be summarily rejected.
- 3. Please enclose non-refundable Tender Document Fee of Rs.1000/- (One Thousand only) in the form of Demand Draft drawn in favor of IIIT-Delhi payable at New Delhi.
- 4. The last date for submission of bids is 4<sup>th</sup> July, 2016 up to 3:00 PM. The Tender Document should be addressed to:

5. The bids shall be opened on the same day i.e. 4<sup>th</sup> July, 2016 at 3:30 PM.

#### SCOPE OF WORK

#### Supply of 40 numbers of Computer Desktops as per description below:

#### TERMS AND CONDITIONS

- 1. The financial bid should be valid for a period of not less than 30 days from the date of opening of bid i.e. 30 days from 4<sup>th</sup> July, 2016
- 2. The product is to be supplied within a period of 2 weeks from the date of issue of Purchase Order (PO) by the Institute.

- 3. The bidder should be attached Authorized Dealer Certificate along with the bid.
- 4. Bids will be opened in the presence of bidder's representatives, who choose to attend on the specified date and time. Only one representative shall be allowed to attend.
- 5. Sealed bid can be sent either by post or by messenger. The responsibility of delivery of bid lies entirely with the bidder.
- 6. Payment will be released after successful commissioning as certified by Officer in Charge of the Institute.
- 7. In the event of a dispute, Director, IIIT-Delhi shall be the sole arbitrator and his decision shall be final and binding on both the parties.
- 8. IIIT-Delhi does not bind itself to accept the lowest or any other offer and reserves the right to accept or reject any or all the offers either in full or in part without assigning any reason.
- 9. In case the reseller is not able to execute the Order, EMD amount of Rs.50, 000/- (Rupees Fifty Thousand only) shall be forfeited.
